NOT LONG AFTER BEGINNING AS ELLIS' CEO, I realized my focus would not only be on the children Ellis serves, but also on Ellis' workforce: those who dedicate their careers to early childhood education and youth development. The stories I read about the impact of the workforce crisis on early childhood education quickly became personal. In short, the early childhood education system in the United States is broken. Despite research showing how critical the first five years of life are for brain and social-emotional development, teachers are not compensated fairly to perform this important work. As a result, fewer teachers are entering and staying in the field. Despite high child care costs that can drain families, revenues simply don't cover the operational expenses of high quality center-based care. Advocacy efforts are underway to appeal to legislators to invest more in early childhood education and care, but a significant gap remains. The gap results in high costs for families, yet persistently low wages for teachers.

At Ellis we are diligent in our efforts to increase teacher salaries in a fiscally responsible manner. We review our compensation, benefits, and policies regularly to ensure we're doing all we can to make Ellis a great place to work. We thank and recognize our teachers liberally, so they know they are valued, respected, and heard. We are exploring the most effective ways to advocate for our workforce by engaging a variety of stakeholders including our teachers, Board, and parents.

To any of you interested in this issue, we invite you to work with us, on behalf of, and alongside, our workforce. Together we can convey our shared view that the education and care of our youngest citizens should be taken as seriously as that of older children, and that their teachers deserve equal respect and compensation. It's always disconcerting when cohorts of people are undervalued based on any characteristic, including occupation. Fortunately, thanks to passionate leaders, advocates, and citizens from the past, we know change is possible. And so it must be for our teachers.

LOOKING TO THE FUTURE

TRANSITION WAS CENTRAL TO 2018 FOR ELLIS. From opening a new School-Age site to gathering for a celebration of the long term service of our retiring CEO, the Ellis community looked fondly on the past as we welcomed the possibilities of the future.

We bid farewell to Leo Delaney who served as Ellis' beloved CEO for 32 years. He transformed Ellis from a small nonprofit with an uncertain future, to a distinguished, leading educational organization responsible for the thriving development of thousands of children over his tenure. To celebrate Leo and all he accomplished for Ellis, supporters gathered to honor his work in October, and generously donated over one million dollars to continue his legacy. These funds are dedicated to supporting ongoing operational expenses and maintaining the quality of our historic buildings.

In partnership with Madison Park Development Corporation, Ellis completed a project to expand our youth program site in Roxbury, which will have a significant impact on the families residing in the community. Ellis' ability to provide School-Age programming at the newly constructed Dewitt Center will enable 22 new families to join the Ellis community and provide those families with supports they may not otherwise have been able to access.




